12 Norfolk County Council Highways Issues

- a) Correspondence relating to the Wisbech Access Strategy (Preferred Short-Term Projects) was considered and discussed; namely the scheme to possibly relocate the A47/Elm High Road Roundabout (Scheme EH3B). Clerk to request further clarification on the scheme.
- b) It was noted that a new dog waste bin has been fitted at Meadowgate Lane and a further one will be installed at Elmside.
- c) It was noted that the overgrown poplar trees at The Wroe have now been cut back.
