687. Norfolk County Council issues.

687.1 An email from NCC regarding their forthcoming consultation on the 2014/15 budget and savings proposals was noted.

688. Norfolk County Council Highways Issues.

688.1 Clerk to contact Cllr. Humphrey to see if he has had any success with getting the hedges at the back of The Wroe trimmed back. If not, Clerk to contact Highways for their help.

689. Footway Lighting issues.

689.1 Nothing to report from the meeting.

690. Playing Field issues.

690.1 Cllr. Waterfield & Cllr. Oliver attended the Playing Field AGM on 8th August. Alex Lane had taken on the roles of both Chairman and Treasurer.

690.2 The Deed has now been signed by Cllr. Graham, Cllr. Waterfield, Stuart Kierman and Jill Ahearn and is back with Fields in Trust for their approval and return. The Deed then legally needs registering with the Land Registry which Brian Bowser will deal with.

690.3 Clerk to try and find some paperwork relating to the bequest from Claude Coates to the PC in the early 1980's. The exact terms given to the PC need to be determined

691. Cemetery issues.

691.1 Terry Wiles has been asked to cut the hedges in the cemetery.

Cllr. Howard left the meeting at 7.41pm.

691.2 To date, no further correspondence has been received from John Maxey after meeting with him on 9th July to determine a suitable access from the cemetery to the proposed future burial ground. The suggested

access was along the rhs of the cemetery (when standing with your back to the church) up to the last oak tree on the rhs and then in a straight line right down to the back. John Maxey agreed to write to Mr & Mrs Howard with this proposal. On going.

691.3 A further faculty will not be required to gain access to the new piece of land.

691.4 After speaking with NALC regarding the legality of borrowing the money from the Claude Coates fund to purchase future burial ground for the parish it would appear that this is feasible but only after seeking approval from the CLG and demonstrating that local residents have been thoroughly consulted regarding the project and associated borrowing. A leaflet included with the Messenger was suggested as a good way to inform all residents. Clerk to try and locate the paperwork relating to the bequest from Claude Coates to determine the 'terms' that the money was left to the PC under as this will be needed to gain approval from the CLG.

Cllr. Howard re-joined the meeting at 7.55pm.

691.5 Cllr. Terrington asked Cllr. Graham how many Marshland St. James residents use St. Edmunds Church in Emneth. Cllr. Graham reported that she thought it was 1.

691.6 Cllr. Wiles reported that the village sign was in desperate need of treating with oil. Cllr. White agreed to follow this up.
