MINUTES

1. Apologies for absence

1.1 Apologies were given for absence as listed above and accepted.

2. Declarations of Pecuniary Interest

2.1 There were no declarations of pecuniary interest made on this month's agenda.

- 4.3.1 Anglia Local Enterprise Partnership is providing £10m towards the £30m savings needing to be made. The Government will provide £10m and NCC £10m.
- 4.3.2 The next council meeting is Tuesday 1st September.

4.4 Parish Councillor Reports/Correspondence –

4.4.1 A briefing session held by BCKLWN on Wednesday 5th August provided information regarding the Government requiring local authorities to maintain a 5 year supply of deliverable housing sites. An Inspector has concluded that the BCKLWN <u>do not</u> have a 5 year land supply and therefore all housing applications are to be considered in the context of *sustainable* development and all normal housing supply policies are deemed to be out of date. There is no set methodology for calculating a 5 year supply but it was stressed that this will not mean 'anything goes' – all applications will be considered individually in the context of whether they are *sustainable* or not.

The adjournment of the examination into the Site Allocations & Development Management Policies Document has no relationship to the high court decision on the 5 year land supply. It is just unfortunate that both events have occurred at the same time. The examination has been adjourned due to concerns raised about the impact of housing proposed on sites of designated European wide importance, compliance with Habitat Regulations & Flooding. The examination is likely to resume end September/early October.

- 4.4.2 It was noted that a Casual Vacancy Notice had been advertised in the village on 31st July advertising the councillor vacancy and that no election will be necessary. Posters will be displayed on the website and around the village advertising the vacancy and interested parties will be invited to attend a council meeting to address the council.
- 4.4.3 It was noted that the NALC councillor training session will take place on Wednesday 23rd September at 7pm at Emneth Central Hall.
- 4.4.4 The certified Annual Return 2014-15 has been received from Mazars and the 'Notice of Conclusion of the Audit' and the Annual Return have been displayed on the village noticeboard and website.
