1. Planning

- 1.1. Apologies were received & accepted as above.
- 1.2 Councillor Waterfield declared an interest in **Planning application 16/00149/F** on the agenda, Construction of four dwellings, Land Off Ladys Drove, Emneth. He would participate in discussions but not vote.

Planning application 16/00086/O

Outline application – Residential development of 5 dwellings

Land on the West side of Hollycroft Road, Emneth

It was resolved to approve the application and comment that this development would enhance the appearance to the entrance to the village.

Planning application 16/00116/F

Conversion of existing derelict warehouse to a single residential property The Old Warehouse, Chapel Lane, Emneth It was resolved to *approve* the application. All in favour.

Planning application 16/00039/F

Proposed single storey rear extension Gladstone Cottages, 48 Church Road, Emneth It was resolved to *approve* the application. All in favour.

Planning application 16/00126/F

Timber frame building at 246 Outwell Road, Emneth

It was resolved to *refuse* the application. The building would be more appropriately situated to the rear of the property. All in favour.

Planning application 16/00149/F

Construction of four dwellings, Land Off Ladys Drove, Emneth Councillor White proposed to *approve* the application.

Councillor Curtis made an amendment to *refuse based on over intensive development of the site*. A vote by a show of hands showed 4 in favour and 5 against. Amendment lost.

The initial proposal from Councillor White to *approve* the application was seconded by Councillor Wiles with 4 in favour and 4 against, 1 abstention. Councillor Waterfield used his casting vote as Chairman to vote *against* the proposal to approve the application. Motion lost.

**Footnote - Planning application 16/00149/F

The Clerk sought advice after the meeting and has determined that a further motion should have been proposed, seconded and voted on in order to correctly bring this item to a close.

An extract from Arnold-Baker on Local Council Administration (para 7.30, page 64 of 9th Edition) states, 'after all amendments have been disposed of it is still necessary to decide by voting on the resolution in its final form as amended or not amended. The fact that an amendment is rejected does not mean that the main resolution is accepted, nor does acceptance of the amendment mean that the resolution as amended is accepted'.
