MINUTES

1 Apologies for absence

1.1 Apologies were given and accepted as above.

2 Declarations of Pecuniary Interest

2.1 No declarations of pecuniary interest were given for any of the items on this month's agenda.

4 Public Forum

There were five members of the public present. Three of them wishing to make representations regarding Planning Application 16/02135/F at item 7.1 on the Agenda – Residential development consisting of x4 one bedroom retirement bungalows at rear of 22 Gaultree Square, Emneth.

Comments received from all three were considered by members before resolving to suspend any decision regarding this application until amended plans have been submitted clearly indicating two car parking spaces per unit together with a sufficiently drawn plan showing the position of the layby at the entrance to the proposed development. 11 in favour, 1 abstention.

7 Planning Applications

7.1 To receive and consider Planning Applications and Decisions since the last meeting

Planning Application 16/02135/F, residential development consisting of x4 one bedroom retirement bungalows at rear of 22 Gaultree Square, Emneth. It was resolved with 11 in favour and 1 abstention to suspend any decision regarding this application until amended plans have been submitted clearly indicating two car parking spaces per unit together with a sufficiently drawn plan showing the position of the lay-by at the entrance to the proposed development.

Planning Application 16/02108/F, proposed new dwelling and detached garage at Land W of 118 Church Road, Emneth. It was resolved with all in favour to not make any comment on this application.

Planning Application 17/00047/O, residential development at land adjacent 83 Ladys Drove, Emneth. It was resolved with all in favour to recommend refusal to this application. The proposed development is of a cramped and over-intensive form and alien in design to its surroundings. Planning Application 16/01776/F, retention of extension of the existing store/shed to provide swimming pool, toilet and shower facilities at 87 Elm High Road, Emneth. It was resolved with all in favour to not make any comment to this application as it was considered that insufficient information had been provided to be able to make a recommendation.

7.2 Decisions

Planning Application 16/01716/CU Change of use of ground floor from pub to restaurant and takeaway also change of use of first floor from bed and breakfast to residential use and addition of flue at 106 Elm High Road – parish council considered this application electronically and recommended approval to the BC on 17 January 2017 with a comment that 'the parish council is keen to encourage rural enterprise in the village and does not wish to see the property fall into neglect'.

Planning Application 16/01894/F Retention of and extension to create four bay stables, hay barn with tack room at Walnut House, Fendyke Road – Permitted by the Borough Council.

Planning Application 16/01624/O Two proposed dwellings Land adjacent 72 Gaultree Square – Permitted by the Borough Council .

Planning Application 16/01696/F Erection of a 108 metre high fence to enclose part of the front of the property. A second 1.8 metre high fence to then be taken down the driveway to meet the garage wall creating an enclosed side garden area at 26 Raceys Close – Refused by the Borough Council.

Planning Application 16/01860/CU Change of use from private swimming pool to spa at Notlems, 45 Hollycroft Road - Permitted by the Borough Council.

Planning Application 16/01663/O Demolition of existing together with associated outbuilding and replacement with up to four dwellings at 2 Church Road – Refused by the Borough Council. **Planning Application 16/02113/LB** Extension and alterations to Dial House, 269 Wisbech Road – Approved by the Borough Council.
