- 1.3 <u>To receive Planning Applications and Decisions</u>

Planning application 16/01153/F, Extension and alterations to dwelling, 17 Elmfield Drive, Emneth The three members of the public present were invited to present their cases for cause for concern regarding this proposed development. Their main concerns were the overall proposed size of the proposal, the overlooking issues for immediate neighbouring properties and the building of such a large development so close to an infilled dyke.

It was resolved to *refuse* this application.

- 1. The size of the proposed development would be extremely imposing and have a detrimental effect on neighbouring properties creating overlooking issues.
- 2. The proposed development is out of character and does not conform with the current street scene.
- 3. The parish council is concerned with building so close to the infilled dyke at this location.

**Planning application 16/01184/LB,** Extension and alterations, Dial House, 269 Wisbech Road, Emneth

It was resolved to make *no comment* on this application for *Listed Building* consent. The Conservation Officer at the Borough Council was aware of the changes required and had been informed by the Agent that they were minimal.
