MINUTES

1 Apologies for absence

1.1 Apologies were given as above and accepted.

2 Declarations of Pecuniary Interest

2.1 Councillor Howard declared an interest in Item 15.2 on this month's agenda.

3 Minutes

3.1 It was resolved to accept the Minutes of the Annual General Meeting of Tuesday 30th May 2017 as a true record of the meeting. These were signed by the Chairman.

4 Public Forum¹

4.1 A representative from the group present expressed their concerns regarding the speeding in the village which would appear to have increased over the last few months especially on the main roads into and out of the village – Lady's Drove, The Wroe, Hollycroft Road, Church Road and Hungate Road. After discussion it was apparent that several residents are keen to volunteer to set up a Community Speedwatch Team. Councillor Groves agreed to progress this with the residents. Councillor Groves, County Councillor Humphrey and the parish council agreed to adopt a three-pronged approach to Norfolk County Council Highways and the Police in a bid to try and secure highway improvements for the village, such as chicanes.

Thirteen members of the public left the meeting.

5 Reports

5.1 Police Report

5.2 **Borough Councillor Report**

- 5.2.1 As part of cost-cutting exercises, the Scrutiny Meetings are now being held every six weeks instead of every four.
- 5.2.2 The first *Community Infrastructure Levy* payments are due this month.
- 5.2.3 The Local Plan Group looking at development through to 2036 has had their first meeting.
- 5.2.4 The *Local Government Boundary Commission* is looking to reduce the amount of wards to 54. Feedback from parish councils is requested.

5.3 County Councillor Report

5.3.1 Following the election and *purdah* restrictions, the County has resumed business as usual.

- 5.3.2 A projected £125m gap has been predicted for three years' time between the growth required and income expected.
- 5.3.3 Discussions have taken place regarding one hundred per cent of business rates being ringfenced for the local area.
- 5.3.4 County are continuing to try and produce balanced budgets.

5.4 Parish Councillor Reports/Correspondence

5.4.1 It was resolved to make a grant offer of £5,000.00 to the Village Hall Committee to help with costs to resurface the car park at the village hall - total project cost circa £20,000.00.

7 Planning Applications

7.1 To receive and consider Planning Applications and Decisions since the last meeting **Planning Application 17/01131/O** Outline Application for one dwelling at Land West of 71 Church Road, Emneth. It was resolved with all in favour to recommend *approval* to this application. **Planning Application 17/01185/O** Outline Application with some matters reserved for proposed residential development at Land to the East of 71 Ladys Drove, Emneth. It was resolved with 6 in favour and 4 abstentions to recommend *approval* to this application.

Planning Application 17/01177/RM Single building plot on land adjacent to existing dwelling at Land adjacent 54 Hollycroft Road, Emneth. It was resolved with all in favour to make *no observations* to this application.

Decisions

Planning Application 17/00840/F Land West Ambridge Way, 118 Church Road, Emneth – variation of condition 1 of planning permission 16/02107/F proposed dwelling and internal garage and temporary retention of static caravan during construction work – permitted. Noted.

Planning Application 17/00680/RM Land North of 86 Hollycroft Road, Emneth, residential development plots 1 and 2 – permitted. Noted.

Planning Application 16/02091/O Hawstead Bungalow, 62 Elmside, Emneth, proposed bungalow – permitted. Noted.

8 General Correspondence

- 8.1 Clerk to follow up with Councillor Waterfield regarding some overhanging trees and bushes at Hungate Road. Clerk to send letters to the properties concerned.
- 8.2 Correspondence was noted from a concerned resident of Hungate Road regarding the speed of vehicles along Hungate Road. This issue formed part of this month's Public Forum. See Item 4.1.
- 8.3 Clerk to write to Anglian Water regarding the overgrowth at their underground reservoir at Edge Bank, Emneth.
- 8.4 Clerk to follow up with the Borough Council regarding the abandoned caravan at Hungate Road.

11 Norfolk County Council Highways Issues

11.1 Clerk to write to three residents regarding trees/shrubs overgrowing onto the highway from their properties, asking them to cut them back to their boundary lines.

12 Footway Lighting issues

12.1 Clerk to report footway light 9020, outside 51 Church Road as out.

13 Playing Field issues

- 13.1 It was resolved with all in favour to accept the quote of £350.00 + VAT from *Reads Groundworks and Drainage* to carry out repairs to the entrance to the playing field. Clerk to liaise with the Playing Field Committee.
- 13.2 Concerns have been growing recently over the increased use of the playing field by dog walkers and the obvious health and safety issues surrounding this. The Borough Council has the power to create *Public Space Protection Orders* which makes it an offence to fail to clear up after a dog on any land to which the public has access. These *Orders* last for three years before they have to renewed or revoked. Emneth Playing Field is currently covered by this section of the *Order*. The *Order* can also provide for either the banning of dogs from land or the requirement to keep dogs on a lead. Emneth Playing Field is NOT currently covered by these sections of the *Order*. Emneth Playing Field could be considered for inclusion when the *Order* is next reviewed in 2018 if so required. On going.

14 Agricultural Holdings

15 Cemetery Issues

- 15.1 It was noted that one of the hedges in the old cemetery needs cutting back. Councillor Waterfield to action.
- 15.2 It was resolved with all in favour to move into a *closed session*, to exclude the public from the meeting, to provide councillors with an update on the acquisition of land for future burial ground for the parish².

Councillor Howard requested a *recorded vote* be taken on any matters that may be voted on during the *closed session* and then left the meeting.

15.3 The Chairman updated councillors with some correspondence that had been received regarding the planning application which is currently being considered at the Borough Council. It was resolved to make no further comments at this time regarding this application.
