MINUTES

1 Apologies for absence

1.1 Apologies were given as above and approved.

4 Public Forum¹

4.1 The meeting was suspended to hold the public forum.

Five of the members of public present were residents concerned with the sale of the canal land at the Elm/Emneth border. The Chairman and County Councillor Humphrey outlined the current position to confirm that both parish councils have committed to jointly purchasing the land in question from Norfolk County Council at a price of £10,000.00. Emneth Parish Council has committed to raising their share (£5,000.00) within a six month period by way of grant funding and fund raising throughout the parish. The future maintenance of the land will be the joint responsibility of Elm and Emneth Parish Councils.
