- d. It was resolved to purchase a further two dog waste bins for the parish; one for the footpath at the top of Elmside (behind the houses along The Wroe) and the other for the top of the former canal

towpath at Collett's Bridge. Installation will take place as soon as permission has been received from Norfolk County Council.

Councillor Groves joined the meeting.

7. Planning Applications

- To receive and consider Planning Applications since the last meeting;
 - Planning Application 20/00559/RM proposed bungalow at Land South East of 62 Elmside, Emneth; it was resolved to approve this application.
 - Planning Application 20/00194/F erection of replacement dwelling at Springfield, 60 Outwell Road, Emneth; it was resolved to *approve* this application.
 - ➤ **Planning Application 20/00675/F** extension to bungalow at 16 Church Road, Emneth; it was resolved to *approve* this application.
- To note any appeal notifications since last meeting; no report.
- To note any decisions made at the Borough Council since last meeting
- Planning application 20/00295/CU, 62 Gaultree Square, Emneth; change of use of dwelling to shop and dwelling. Approved.
- 8 It was noted that the annual internal audit was carried out on 18th May 2020.
- 9 It was resolved to approve the 2019 2020 End of Year Accounts⁴ as prepared by the Clerk.
- 10 All the questions from *Section 1 of the Annual Governance Statement 2019 20*20 were read out by the Clerk and it was resolved to approve all items in this section of the governance statement.
- 11 It was resolved to approve the figures as set out in *Section 2 of the Annual Governance Statement 2019 2020*.

12 Cemetery Issues

- a) Works to the high-risk trees in the churchyard are now complete. Members now need to consider when to address works to the medium risk trees as set out in the 2018 survey from CGM Group.
- b) A limb from an oak tree recently fell into the cemetery damaging one ashes memorial tablet and several personal mementos on various tablets. The limb has now been cut up and removed. Apologies to any families who have had their mementos damaged; these have all been collected by the parish council and will be stored in a safe place for two months should anyone wish to collect their personal items. This fallen limb was just too heavy for the tree to sustain and was growing hidden from sight within the conifer bush surrounding it.
- c) Works to reduce the height by 50% of the Robinia in the churchyard overhanging the church wall and footpath/highway will commence w/c 1st June 2020 by CGM Group.
- d) A quote to build up and re-turf five graves in the cemetery has been requested from CGM Group.
- e) It was resolved for the Chairman to obtain a quote from a new local contractor for grounds maintenance works in the churchyard/cemetery to compare prices.
- f) Full grave burials are being offered to *residents* of the parish *only* as of 1st January 2020⁵. It should be noted that the provision of cemetery services within a parish is a discretionary service.

13 Playing Field Issues

It had been resolved earlier this year for Councillor McCourt to progress with a contractor for the grinding out of the poplar tree stumps at the playing field and expenditure of £2,000.00 has been approved for this. Ongoing.

14 To receive a report from the Borough Council

It was noted that **Planning Application 19/01416/O** Longridge, 37 Elm High Road, Emneth is being considered at the Planning Committee of the Borough Council via Zoom on 1st June 2020. Councillor Howard will be representing the parish council's objection to this application at this meeting.

15 To receive a report from the County Council

It was noted that the Fire Service is working very closely with the Ambulance Service during the ongoing coronavirus pandemic.
