- 1.2 No declarations of pecuniary interest were made on any item on the agenda.
- 1.3 <u>To receive Planning Applications and Decisions</u>

Planning application 16/01686/F Extension and alterations to shop and dwelling to form enlarged sales and storage area along with separate access to dwelling at Emneth Village Stores, 22 Gaultree Squares, Emneth. It was resolved to *approve* the application with 6 in favour, 2 abstentions.

Planning application 16/01631/F Proposed replacement farm shop and sales including removal of existing container and associated structures at Tramways, Outwell Road, Emneth. It was resolved to *approve* the application with all in favour.

Planning application 16/01655/F Change of use from agricultural building to residential at Strawberry Fields, 28 Mill Road, Emneth. It was resolved to *refuse* the application with all in favour. It is outside the development boundary and no case had been made for an exception dwelling.

Planning application 16/01663/O Demolition of existing together with associated outbuilding and replacement with up to 4 dwellings at 2 Church Road, Emneth. It was resolved to *defer* consideration of this application to the 25 October Ordinary Meeting due to internet access issues.
