7 Planning Applications

- 7.1 To receive and consider *Planning Applications* and *Decisions* since the last meeting
- 7.1.1 **Planning Application 17/01555/F (amended)**, Variation of Condition 2 of planning permission 16/00149/F Construction of four dwellings at Land off Ladys Drove, Emneth. It was resolved with all in favour to recommend *approval* to the amendments.

13 Playing Field issues

- 13.1 A discussion ensued around the feasibility of adding some type of structure to the left hand side of the pavilion to provide potential space for hiring out to local member groups etc. The idea was supported in principle on the proviso that it would be fully-funded by grants etc. A lot more information would be required before full support for the project would be given.
- 13.2 Councillor Groves agreed to take a look at the condition of the car park. The entrance has been repaired recently but pot holes in the main car park have been reported recently.

14 Agricultural Holdings

14.1 Annual invoices have now been sent out.

15 Cemetery Issues

15.1 A site meeting at the Hungate Road allotments had taken place on 23rd October to assess its suitability for providing further burial ground for the village. It was noted that approval would need to be obtained from the Secretary of State for the disposal of allotment land. Clerk to progress this with the *Norfolk Association of Local Councils*. Clerk to contact the *King's Lynn Internal Drainage Board* to make enquiries about using the frontage of the land as an entry point, potentially building a culvert and piping the dyke. Clerk to also instigate enquiries with the *Environment Agency* surrounding potential ground water pollution tests.

15.2 The Clerk reported two graves in the cemetery that have placed white stones on graves. These need to be removed immediately. Letters have been written.
