REPORT OF PARISH/POLICE LIAISON OFFICER & OTHER POLICE MATTERS.

PCSO S Cockrell updated the council on the latest Crime Statistics and measures being taken in the parish to combat anti-social behaviour. He advised members that there will be a police presence in the village over Halloween and on bonfire night. A report on the proceedings at the last CAG/LAG meetings was received.

Members noted a list of logged telephone calls received by the police regarding nuisance at Hagbeach Hall Close during July 2008.

At 7.22pm the Chairman suspended the meeting to allow a parishioner to speak to the council regarding the recent sale of agricultural land off Fendyke Road. The parishioner expressed concern that the sale had not been widely advertised. She stated that she had expressed an interest to a parish councillor but had heard nothing more until learning the land had been sold. Councillor N Terrington expressed concern that her interest in the land had not been made known to the council.

The Chairman advised her that he was satisfied that details of the proposed sale had been widely passed around verbally. He apologised for the fact that council had not been made aware of her interest prior to the sale.

The parishioner then asked if something could be done about the condition of Fendyke Road, the surface of which was badly broken. The Chairman assured her that the matter would be reported to the Highways Authority.

166/08 HIGHWAY MATTERS

New matters reported:

- Potholes & Hedges despite several requests to the Highways Department no improvements have been made. The Chairman reported that he had requested a visit by the Highways Officer and had been told that he will be contacted before such visit so that he can accompany him (Highways Officer).
- Gaultree Square/Church Road Junction. It was reported that there are a lot of fallen leaves on the footpath. It was suggested that the Road Sweeper might be prepared to clear them away. The Chairman will ask.
- Betsys Pad the Chairman read out a letter received from a resident whose garden backs on to Betsys Pad. She complains that there is a tree over-hanging her garden that she is concerned about. She also reported rubbish had been dumped in an old drain. An inspection will be carried out and reported on at the next meeting.
- Road Markings Council received a report that road markings on the A47 roundabout were causing traffic hold-ups. The Chairman explained the markings had been done by the Highways Authority to put traffic in the correct lanes as it approaches the roundabout.

50mph Seed Limit

A copy of the proposed RTO to impose a 50mph speed limit along the A1101 was circulated. It was noted that Council's request for an extension to the original proposals had been ignored. The Clerk was asked to write again to request the limit be extended to include the junction with Outwell Road.

The Wroe

It was reported that the internally-lit 'Give Way' sign at the junction of Then Wroe and Gaultree Square was flickering. The Clerk will report to the Highways Department.

167/08 PLAYING FIELD MATTERS

Pest Control

The Chairman reported that Pestforce had attended the playing field and had been successful in reducing the number of moles. The Clerk read out a letter from Pestforce outlining their charges. It was proposed, seconded and agreed to accept a yearly contract at a cost of £900.00 plus vat. The cost of the recent work undertaken would be included in that sum.

Poplar Trees

There was discussion regarding the height of the poplar trees between the two fields. It was agreed that they should be cut down to 15/20 foot maximum height. Councillor McCourt will make enquiries regarding the availability of a Tree Surgeon.

The Council's response to the Boundary Committee was noted. The Chairman explained that the submission had been prepared jointly with representatives of Marshland St James Parish Council but each council had sent their own submission.

170/08 AGRICULTURAL HOLDINGS MATTERS

Hungate Road Holdings

Council received a report that Mr Hill had agreed to exchange some of his holdings and move into one section of the field, keeping 6 acres in total. The rest of the field would then be worked by Mr Lankfer for one year. New Leases and 'Notice to Quit' where applicable will be prepared.

The Chairman drew attention to the time (9.30pm) and asked members if they wished to continue the meeting to deal with remaining matters. It was agreed to do so.

171/08 CEMETERY MATTERS

1 Working Party Report

Council received a report that netting had been put back around one memorial stone. After discussion it was decided that this could not be permitted and the Clerk was instructed to contact next-of-kin and ask for it to be removed.

Members received a report from the working party regarding a possible infringement of regulations on the size of a newly-installed memorial. A further inspection will be conducted and action taken as necessary.

There was discussion regarding the length of time between grass cutting as lately the grass had become very long before it had been cut resulting in unsightly clumps of wet grass lying about? CGM will be asked if they have changed their cutting routine.

Cemetery Extension

The Clerk reported that despite chasing letters there had been no further contact from the Borough Council. More attempts will be made to contact the officer concerned.

Interference with Graves

It was reported that on at least one occasion a grave had been tampered with and a flower vase stolen and replaced with an old one. The situation will be monitored.
