- 156/10 APOLOGIES for absence.

- 157/10 COUNCILLORS' DECLARATIONS OF INTEREST IN ITEMS ON THE AGENDA AS REQUIRED BY THE PARISH COUNCIL'S CODE OF CONDUCT 2007

  None declared.
- MINUTES of the Ordinary Parish Council Meeting held on Tuesday 31st August 2010 had previously been distributed to all Councillors with copies being made available for public perusal at the post office, the Central Hall notice board and the parish council website. Councillor N Terrington pointed out that he had not wished the whole of the final paragraph of Minute 125/10 to be deleted but only the final sentence. The Clerk agreed that this comment would be noted after which they were signed by the Chairman as a true record.
- 159/10 REPORT OF PARISH/POLICE LIAISON OFFICER & OTHER POLICE MATTERS.

There was no police officer present.

The Chairman gave a report on the proceedings of the first SNAP meeting that had been held at Downham Market. He said that there was little opportunity for public participation and issues for priority treatment were decided by the Borough Council reps and the police. There had been no public voting. He said that he had been unable to raise the subject of improper parking in the parish and he had since emailed the SNT. A list of the priorities arising from the meeting was circulated.

# 160/10 CHAIRMAN'S CORRESPONDENCE

- The Chairman read out a letter that he had received from the Clerk giving notice of her resignation wef 30<sup>th</sup> November 2010. It was agreed that advertisements should be placed with the county associations of Norfolk & Cambridgeshire.
- The Chairman read out a letter he had received from Councillor N Terrington challenging the accuracy of the final sentence of Minute 140/10 (see Minute 158/10). He also read out a letter from Councillor Terrington that stated his displeasure at not being permitted to stress his views on the consultation on Council Tax Referendum. He wished to know what action had been taken. The Chairman informed him that he and the Clerk had prepared and despatched a response as was agreed at the last meeting and was recorded as such in Minute 153/10. Councillor Terrington also stated that he was not satisfied that the Agenda allowed for Parishioners Forum at the commencement of the meeting whereas he wished it to be during the meeting. In the event there were no members of the public present who wished to raise any matters. Councillor Terrington further stated that he was concerned that the IDB had not responded to the council's request to investigate various drainage matters in the parish and he wished this subject to be included on the Agenda of all future meetings whether or not there is anything to report.
- The Chairman read out a letter he had received from the CAB that advised him that
  the local sessions were still running well. He read out an article that had appeared in
  the local press stating that the Fenland CAB had lost its contract with the Legal
  Services Commission which could mean the loss of the services in Fenland. The
  matter is on-going.
