- 7.3 On a proposal from Cllr. McCourt, seconded by Cllr. Fleet with all in favour it was resolved to make a donation of £50.00 to The Norfolk Hospice, Tapping House.

8. Borough Council of KL&WN issues

8.1 A letter from the BCKLWN regarding the threshold for affordable housing requirements in West Norfolk was noted.

9. Norfolk County Council issues

9.1 Clerk to report a damaged Anglian Water manhole cover opposite 58 Gaultree Square. The cover is loose and the manhole sinking, the tarmac is loose around it.

10. Norfolk County Council Highways Issues

10.1 On a proposal from Cllr. McCourt, seconded by Cllr Curtis with 10 in favour, 1 against, it was resolved to spend £3,000 on a trod with edging for Hungate Road from The Lovells to the playing field. The other £3,000 to be paid by Norfolk County Council via the 2016/17 Parish Partnership Scheme. This will be 100mm subbase with a surface dressed surface.

12. Playing Field issues

- 12.1 CCTV has been installed and will be 'live' soon.
- 12.2 Morton & Hall had provided a structural report for the old pavilion listing repair requirements for its continued use as a store. On a proposal from Cllr. Curtis, seconded by Cllr. Harper with all in favour it was resolved to ask English Brothers to provide a quote for the trusses required for the new roof.

Cllr. McCourt left the meeting at 8.10pm.

13. Cemetery issues

13.1 Cllrs. Curtis, Graham & Waterfield had met to carry out an inspection of the cemetery. It was decided that there is roughly enough space for a further 5 years. On a proposal from Cllr. Harper, seconded by Cllr. Curtis with all in favour it was resolved to approach 3 companies for a quote to pipe and fill the dyke in the cemetery to provide further space for burials.

14. Agricultural holdings

14.1 Cllr. Waterfield to contact Mr. Lankfer to confirm his tariff for the coming year – to be the same as Mr. R. Hill (£91.16/acre 2014/15 price) and then an increase of 5% each year up to & including 2016/17 payment. It was agreed that there would be a 5% increase on land rents for 5 consecutive years as of 2012/13.
