1 Apologies for absence

- a) 18/01257/F, Proposed erection of x2 semi-detached dwellings including demolition of existing dwelling on site at Oakwood, 44 Hollycroft Road, Emneth. It was resolved to *refuse* the application, single storey dwellings only would be preferred.
- b) 18/01464/RM, Construction of 117 dwellings at Land East of 11-37 Elm High Road, Emneth. It was resolved to *refuse* the application until such time access arrangements are improved.
- c) 18/01361/F, Removal of existing conservatory and erection of single storey side extension at Dial Cottage, 261 Wisbech Road, Outwell. It was resolved to *approve* the application.

Decisions made by the Borough Council since last meeting

a) 18/01001/F, 12 Church Road, Emneth – Side and rear two storey extensions and new porch area. Approved.
