MINUTES

1. Welcome

a) The Chairman welcomed everyone to the meeting.

2. Apologies

a) Apologies for absence were given as above and approved.

3. Declarations of Pecuniary Interest

a) No declarations of pecuniary interest were given for any item on this month's agenda.

4. Public Forum

The meeting was temporarily suspended to hold the Public Forum.

A resident of Hunters Rowe was present to request further support from the parish council to change the access arrangements for *Planning Application 18/01464/RM*, construction of 117 dwellings at Land East of 11-37 Elm High Road, Emneth. Currently the only access for this proposed development is through Hunters Rowe which is totally unacceptable as the road is not wide enough for the predicted size of vehicles requiring access to the site nor suitable for the predicted extra volume of traffic. There are safety concerns surrounding the use of the current suggested access also. It was resolved for the parish council to support the residents of Hunters Rowe in their response to the current reserved matters application¹ under consideration and to draft a letter to Elizabeth Truss MP in support of the residents of Hunters Rowe in objecting to the current access arrangements for the proposed development.

5. Planning

5.1 To receive and consider Planning Applications and Decisions/Appeal Notices from the Borough Council since last meeting.

Planning Application 18/01464/RMM, Construction of 117 dwellings at Land East of 11-37 Elm High Road, Emneth. It was resolved to respond to the Borough Council to report that the current proposed access road for this development is not suitable; it is not wide enough for the predicted size of vehicles requiring access to the site nor suitable for the predicted extra volume of traffic. There are safety concerns surrounding the use of this suggested access also.
