1 Welcome

The Chairman welcomed everyone to the meeting.

2 To receive apologies for absence

No apologies had been given for this month's meeting.

- 3 Members' Declarations of Interests in items on the agenda and any dispensations required considered Councillor Finnis declared an interest in Item¹ 10a): Planning Application 23/02041/F.
- 4 Open Forum for Public Participation (15 minutes)
 - a) A resident of Hollycroft Road was present concerned with the speeding traffic along Hollycroft Road particularly at school drop-off and pick-up times. This is a perennial problem in the village; the SAM2 camera has been deployed at this location on several occasions but does not seem to have too much of a long-term impact on the problem. The Clerk will address the issue with NCC Highways once more on behalf of the resident but for the purpose of the Minutes historically it has been the costs involved in the requirement to carry out a feasibility study for this type of work that has made it unattainable for the Parish Council.

Councillor Finnis joined the meeting.

- b) The Chairman of the Emneth Over 60's Club was present to request a donation of £300.00 for their Christmas Party. It was resolved to approve this expenditure as a one-off payment and Members suggested that the Club encourage their Members to make a contribution to their Christmas Party next year.
- c) A resident of Mill Road was present to report his objections to Planning Application 23/02041/F detached garden room and store at Lane Cottage, 44 Church Road, Emneth; all points were noted.
- 5 To approve the Minutes of the meeting held on 7th November 2023

It was resolved with all in favour to approve the Minutes of last month's meeting and these were signed as a true record by the Chairman.

- 6 Clerk to provide an update on any matters not included on this month's agenda
 - a) DJK Services has not yet cut the hedges in the churchyard.
 - b) The Red Book Valuation on all Parish Council-owned agricultural land will be carried out early in the New Year by Maxey Grounds.
 - c) Repairs to the church wall are still awaited.
 - d) Still awaiting approval from the Diocese and the Borough Council for permission to pipe the dyke at the cemetery to extend the ashes plots over the dyke² to provide further burial plots for the Parish.
 - e) Works to the trees in the churchyards and the cemetery will take place late December 2023.

7 To receive a report from Norfolk County Council

- a) The County Deal has been agreed in principle (to transfer key powers and funding to Norfolk) known as a level three County Deal; this includes a £20m per year investment fund plus powers and funding for transport, brownfield regeneration and skills.
- b) Councillor Wiles reported ongoing issues with flooding at Elmside.
- c) It was resolved for Councillor Groves and Councillor Burgess-Lee to attend a meeting at the School with Councillor Dawson to discuss parking issues along Hollycroft Road / Gaultree Square.
- d) It was noted that Marshland St. James Parish Council had also confirmed that several residents miss the once-weekly bus service to King's Lynn. Councillor Dawson agreed to follow up on behalf of Emneth Parish Council.

8 To receive a report from the Borough Council

 - Planning application 23//02015/F retrospective application for change of use from residential to part residential part tearoom at Sweet Things Savoury, 33 Gaultree Square, Emneth; it was resolved to support this application.
